Client fees and insurance were 48% of revenue and the county contract 24%. Counseling staff and contractors were 69% of expenses. The fee fund reduced fee revenue by \$61,000, so that nobody was turned away for money.

Part III · Program service accomplishments — sample for 2025

MISSION

Counseling for people and families in Larkspur County, whatever they can pay, from licensed counselors, with the wait and the fee posted in public.

PROGRAM 1 · COUNSELING

Individual, couples and family counseling on a sliding fee from \$30 to \$140 a session. In 2025, 430 people and families were seen in 5,900 sessions; the median wait from a first call to a first session was 21 days; 3 in 5 of sessions were billed below cost and the fee fund covered \$61,000. The center publishes how each number is counted and makes no outcome claims.

PROGRAM 2 · GROUPS

Parenting, grief, teen anxiety skills, DBT skills and a Spanish-language parenting group, each with its state (open, waitlist, full) posted on the website and edited by staff.

PROGRAM 3 · SHORT-TERM SUPPORT

Up to six sessions, no diagnosis, no fee, under the county behavioral-health contract, for a hard month.

COUNSELORS

6 licensed counselors, each listed publicly with licence type and number as the state advertising rule requires, with languages and whether they are taking new clients.

PUBLIC DISCLOSURE

The three most recent returns and the exemption letter are published on the center's website and available on request. The center reports the rule; it does not advise on it.
